6. Once the grant award is confirmed, a non-refund policy applies to all monies paid.
7. Training materials shall be provided to the student at no additional charge by the provider.
8. Students are expected to put forth a good faith effort to apply their training to a career application as a Sustainability Office with a firm or as a Green Consultant in their community.
9. No job placement programs are provided through the training firm.
10. Trademarks offered by the training program are reserved by the trademark owner and students are advised to comply with the rights and limitations of such trademarks.
